### **Board News:**

- 1. The Board approved three new Board members to fill vacancies Bo Collette to the class of 2018 and April Barker and Karen Darby to the class of 2020.
- 2. Jennifer Henson was voted in as chairperson of the Board. Jerry Yates was voted in as President of the Chamber.
- 3. Set up committees for upcoming events:

- 4. Sara Van Horn volunteered to make 2 banners for out front of our building.
- 5. LGAA art show on the interior walls of our building October 14.
- 6. The Board approved these changes to the bylaws, which now need to be approved at this meeting:

In Article III Section 4, the proposal is that the last sentence be deleted. That will give us more flexibility in how we vote. Simple measures could be voted on through email, for instance. Elections would still be by paper ballot.

In Article VI Section 1, the proposal is to make it so that only candidates for officer have to meet the six month membership and three meeting rule. Candidates for board member would just have to be members in good standing. This proposal came about because it appears that the only way to have a full slate of candidates this year to to include brand new members.

#### **Business:**

- 3. Discussed who else wants to be on the various event committees?
- 4. We need door prizes and help with the teachers' breakfast.
- 5. If we're approved for Paint Days, we'll paint the outside of our new building.
- 6. We approved a motion to make all dues due each January instead of on the anniversary of a member's joining, starting January 2018. Dues will be raised then to \$20 for individuals, \$30 for nonprofits and \$50 for businesses. Businesses will continue to have

- 2 voting members, but unlimited numbers may attend meetings and help with events.
- 7. We discussed having a member banquet, perhaps in March. Suggested speakers were Ben Sherrer and Darrell Moore.
